BAY, ALASKA, AMENDING TITLE 18-HARBOR, CHAPTER 18.50-
ENFORCEMENT, SECTIONS 18.50.020-PENALTIES


BE IT ENACTED BY THE CITY COUNCIL FOR THE CITY OF THORNE
BAY, ALASKA;

- Section 1. Classification. This ordinance is of a
general and permanent nature, the
chapter and section hereby amended
shall be added to the Thorne Bay
Municipal Code.
- Section 2. Severability. If any provisions of
this ordinance or any application
thereof to any person or circumstances
is held invalid, the circumstances
shall not be affected thereby.
- Section 3. Amendment of section. The title and
chapter of Title 18-Harbor, Chapter
18.50 Enforcement, Section
18.30.020-Penalties is hereby added to
25111the Thorne Bay Municipal Code.
- Section 4. Effective Date. This ordinance shall
become effective upon adoption.

**Title 18
Harbor
Chapter 18.50
Enforcement**

Section-

18.50.020 Penalties. A. Every act prohibited by this title is unlawful and may be enjoined by judicial order. The below-listed acts shall be subject to civil penalties, in amounts set forth below, not to exceed three hundred dollars per violation. Each act or violation and every day upon which a violation occurs or continues constitutes a separate offense.

B. Acts subject to civil penalty and penalty amounts are:

Description of Offenses

1. Overtime parking
2. Parking in loading zone
3. Loose dog or animal
4. Other violations of this title not specifically set forth in this section.

First offense	\$ 25.00
Second offense within one year	50.00
Third offense within one year	100.00
Fourth and subsequent within one year	Mandatory

Description of Offenses

5. Speeding and excessive wake
6. Obstructing float
7. Unauthorized use of another stall

Number of Offenses

First offense	\$ 25.00
Second offense within one year	50.00

Third offense within one year	100.00
Fourth and subsequent within one year	Mandatory

Description of Offenses

8. Leaving vessel in sunken condition
9. Causing a fire hazard

Number of Offenses

First offense	\$ 50.00
Second offense within one year	100.00
Third offense within one year	200.00
Fourth and subsequent within one year	Mandatory

Hearing with the Harbor Commission

In addition to fine set forth above, violators shall be subject to an additional fine consisting of the actual cost to the city to remedy the condition causing offenses numbered 8 and 9 above. (Ord. 97-22 § 3(part), 1997; Ord. 89-30 § 5(part), 1989)
