6. ADMINISTRATIVE REPORTS: (City Administrator & City Clerk)

Wayne Benner gave an administrative report.

- Meeting with the Administrators from Craig and Klawock tomorrow to discuss budgets. Sounds like Klawock is going to be rewriting their entire finance code.
- Discount dump day (one Day only) is scheduled for Saturday May 6 from 9 to 3.
- WM will be on POW on and after the last weekend of May to visit communities and look at scrap metal sites.
- About half way through the re-write of the zoning ordinances that hopefully makes the document more user friendly
- Ordinance 17-05-16-01, Amending Title 17, Chapter 17.04.040 adds language for
- communications-telecommunications facilities to be inserted in the code.

- Ordinance 17-05-16-02, Amending Title 17, Chapters 17-04 Zoning to allow for communications-telecommunications facilities outright or through the conditional use
- process in the various zones.
- Ordinance 17-05-16-03, Clarifies Waivers for lots over 5 acres which are regulated by state law and waivers from the full subdivision process for lots under 5 acres which specific criteria.
 - Ordinance 17-05-16-04, Amending title 3-revenue and finance, Section 3.17.110 raises the fee for sales tax exemption from \$10 to \$15 for Sales tax and eliminate Sales tax exemptions for all types of Alcoholic Beverages and all types of Tobacco products.
 - Ordinance 17-06-06-01, Amending Title 17 Zoning to add definitions for Marijuana establishments, cultivation processing, testing and selling and establishes the approval of any of these steps through a special use permit.
 - Ordinance 17-06-06-02, Amending Title 9-Public Peace Morals and Welfare to add enforcement and regulations for Marijuana consumption and licensing.
 - Both these ordinances are based on the Sitka Ordinance per the council request and set up for at least 3 readings.
 - Ordinance 17-05-02-01, amending Title 2 Administration and Personnel adding as subsection to address short hour employee sick leave accrual. The code addressed short hour employee annual leave accrual but did not carry forward the sick leave portion. Something that was overlooked when the ordinance was created and until recently was never an issue.
 - Ordinance 17-05-02-02 Amending the FY17 Budget is the last quarterly amendment prior to setting the FY 18 Budget. The numbers on this amendment have already changed (for the god) since this was introduced.

Expenditures over \$2000: We have a freeze on expenditures unless absolutely necessary. Same steps we do each spring as I do not believe in spending all the money in you budget just because we budgeted the money.

Harbors and Parks: Shane has replaced a section of bull rail on the guest dock and is working on replacing the skirting around the float plane dock.

Streets and Roads: Streets have been swept. Shoulders have been peeled back and will be doing the clean up as time permits. Max and OVK have managed to do some good on the Kasaan and Southside roads.

Water and Sewer: Sam has been off having knee surgery and taking the time to do last minute studying for his water certification exam this month. The tree removal has slowed a little so we can sort through the logs and see if any may be usable for the picnic shelter at the park.

Solid Waste: Busy day coming up Saturday and most employees will be taking a turn helping out as this program takes a lot of labor.

Law Enforcement: Buck is out and about.

FIRE/EMS: The fire truck we received from Haines is being taken to Tracy to have him look at some seals that should be replaced. The ambulance also needs to have some seals looked at when he is done with the fire truck.

Library: Ashely Richardson, Marks replacement, is here and rapidly trying to understand fhorne Bay.
