This meeting was preceded by a Planning & Zoning Workshop at 5:00 p.m. to review the current zoning code

1. CALL TO ORDER:

Mayor Gould called the meeting to order at 6:30 p.m.

2. PLEDGE TO FLAG:

The audience and council stood for the pledge to the flag.

ROLL CALL:

4. APPROVAL OF AGENDA:

Gould moved to approve the agenda striking the minutes of the March 21, 2017, City Council Meeting. Edenfield seconded the motion. There was no further discussion.

5. MAYOR'S REPORT:

Mayor Gould reported on POWCAC and POWLAT Meetings held in March and stated the meetings had a great turn out of people.

- 6. ADMINISTRATIVE REPORTS: (City Administrator & City Clerk)
 - POWCAC meeting ---- discussion focused around communication, update on the POWLAT and SE Conference and the dumbing down of service to TB
 - POWLAT meeting ---- spent the day discussing timber proposals, stream restoration proposals, getting projects on maps, and acceptance and rejection of projects
 - SEASWA meeting ---- WM, legal counsels and board members hashed out last minute details in agreements so we should see a final agreement shortly.

- I believe we are just about finished with the general WM Agreement and now will have to work on the Thorne Bay agreement
- Discount dump day (one Day only). If the city chooses to hold the discounted dump day I think there needs to be some conditions put in place. The intent of the cleanup day is for people to cleanup. Not to bring in a year's worth of garbage or a year's worth of trash they have accumulated just waiting for the discount day as several did last year One option is a sliding scale that first load at discount price, second load 50% more and 3 third load or more at normal dump rate. Another is just give discount if everything is sorted so staff does not have to do the sorting. Another option is no discount for household trash. I also think the cost should go up on the items that need to be disposed of because of the cost to bale or bury. If it is a full load of burnable and clean scrap metal possibly free. Date has not been set as trying to work schedules as this day requires all staff to participate. Will know by next meeting.
- Establishing a liquor and tobacco tax to help fund emergency services. this has been talked about for the last three years as a means of helping fund Fire and EMS operations. It is estimated that the city could collect about \$13,000 with an additional 4 percent tax. But we would request the market separate out the sales to get a more current estimate.
- Local Improvement District is also an option to generate revenue for specific projects. This would be a means for a neighborhood or specific area to fund or help fund a specific project that benefits them. This is not a city initiated process but a public initiated process. The city is the entity that puts together and implements the project.
- Marijuana ordinance would put in place regulations that the city might want
 to impose on the use, sale and manufacture including taxes, locations, etc.
 That is if you want to implement anything more than State law stipulates.
 Both this and the LID ordinance you have are only examples. Other
 communities also have ordinances that we can look at to pick and choose
 what best fits Thorne Bay
- Approval of additional boat stalls for Adventure Alaska is their yearly request.
- Ordinance 17-04-18-01, amending Title 3-Revenue and Finance is amending
 the section on investments allowing the expenditure of Community
 Development Sales Tax Proceeds for funding essential services through a loan
 program. This added section allows the city to develop a loan short term to
 help business expand or repair essential services. This is done in many
 communities as a means to help retain and grow the economy of the
 community.

- Ordinance 17-03-21-01, amending Title 3 Revenue and Finance....as stated at the last meeting these suggested changes help clarify parts of the revenue side of the code. They do not address any of the exemptions which will be discussed at a later date.
- Ordinance 17-02-07-02, amending Title 18 Harbor, Chapter 18.3-Rules for the
 use of the Harbor Facility adds clarification to current state and federal
 identifications, and since motorized vehicles are allowed on the floats removes
 "motorized vehicles" from being prohibited. The issue of parking and fuel have
 been removed and will be discussed on a later date.

Expenditures over \$2000: Every three years the city must have a Sanitary Survey completed on the utilities. Three years ago, we hired DOWL to do the study and since that time they have been working on several utility projects. Since they are currently working on the water and sewer improvements for VSW I am recommending they do the 2017 study as the two go hand in hand.

Harbors and Parks: Work has started on Davidson Landing restrooms and addition to fire hall for water storage tanks. In excavating behind the firehall an old drain field was discovered.

Streets and Roads: Our request for rental of SE Roadbuilders sweeper has been made. OVK is also selling a small dump truck with sander and plow, grader, roller, and possible other equipment. I am waiting to find out prices.

Water and Sewer: Been working on clean up, routine maintenance and providing operational information to DOWL.

Solid Waste: After Mathew Peterson from Republic Services was on site we have some other options to review in how containers can be loaded with bales. There may be some cash outlay for equipment but make the loading easier and quicker and we can do it without major site work. The other part of baling to ship is we need to start inspecting the trash and pulling out hazardous items.

Law Enforcement: On the list for Buck is ticketing the numerous cars that have outdated vehicles registrations. One an Idaho plate with last registration in 2012. **FIRE/EMS:** Appreciation Dinner.

Carlson inquired about the timeline for the public restroom project for Davidson Landing. Wayne Benner replied that there was no timeline established at this time, but the City is currently working on the project.

10. NEW BUSINESS:

A. <u>Discuss introducing an Ordinance to placing the question of establishing a Liquor and Tobacco Tax on the next Regular Municipal Election held in October of 2017, discussion and action item:</u>

Gould moved to draft an ordinance to place the question of adding additional tax on tobacco and alcohol sales that would fund the Fire and EMS departments, on the October 2017 General Municipal Election. McDonald seconded the motion. Hartwell suggested that Thorne Bay work with Craig and Klawock to find out what they do for the Alcohol and Tobacco Tax and make sure that they do the same so Thorne Bay does not lose on revenue. Gould agreed with Hartwell. McDonald inquired if this tax would be to replace lost revenue. Gould stated the tax would help to generate revenue, Craig has a property tax, so they have more revenue sources than Thorne Bay. Gould stated the question of establishing an alcohol and tobacco tax would have to go before a vote of the people during a regular or special election. Slayton stated he supported the people voting on the question, but wanted to support local business and not drive it away. Slayton suggested finding out what the business's that sell these items thought of the tax. Gould agreed. There was further discussion.

There was a suggestion that the ordinance include that a certain percentage of property owners would have to agree to the improvements. There was further discussion.
