CERTIFICATE

Boundaries of the City of Thorne Bay

I, Mike Irwin, Commissioner of the Alaska Department of Community and Regional Affairs, hereby certify that the following is a true and accurate description of the corporate boundaries of the City of Thorne Bay. The described boundaries include approximately 960 acres annexed to the City of Thorne Bay effective August 25, 1998.*

The post-annexation corporate boundaries of the City of Thorne Bay are described as follows:

On August 17, 1998, the U.S. Justice Department precleared the annexation under the Federal Voting Rights Act (Justice Department file: DJ 166-012-3). The City of Thorne Bay provided documentation of the preclearance to the Department of Community and Regional Affairs on August 25, 1998. Pursuant to 19 AAC 10.630, the annexation took effect August 25, 1998.

Section line locations are based upon the U.S.G.S. 1:63,360 Craig (C-2), Alaska 1949, limited revision 1988. Descriptions of boundaries that exist upon coastal water ways are identified at the locations where section lines and corners would exist as if describing land.

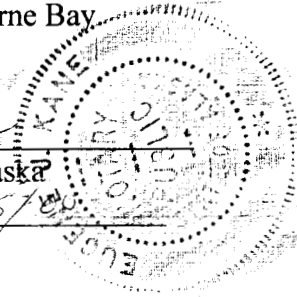
