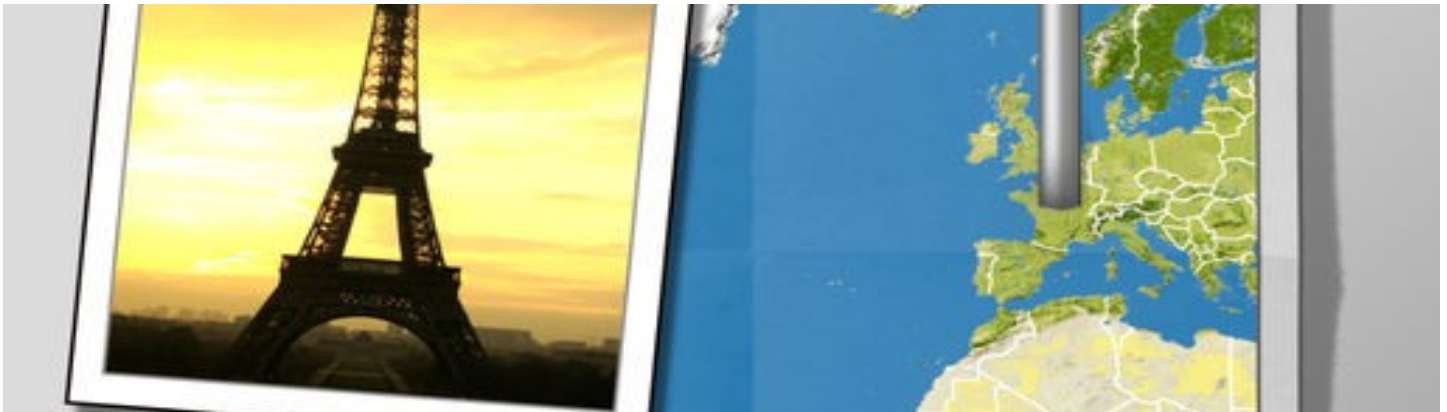
ANNUAL THORNE BAY FISHING DERBY:

CODE ENFORCEMENT OF- FICER

The City Council appointed Robert Hartwell, as the City's Code Enforcement Officer

The Code Enforcement Officer helps to reduce the zoning violations and to protect the interest of property owners within Thorne Bay by ensuring that the buildings and land in a municipality are in accordance with housing and zoning regulations.

They can also investigate the abandonment of vehicles, as these also fall under the category of maintaining the quality of the municipality.

The Code Enforcement Officer investigates written complaints for zoning and parking violations and takes appropriate action to gain compliance through:

- ◆ Negotiated compliance and/or
- ◆ Administrative actions such as issuing citations for violations

ACTIONABLE ITEMS FOR THE JUNE 18TH MEETING ARE STILL PENDING:

POSSIBLE ORDINANCE INTRODUCTIONS:

- ◆ There are two ordinances being drafted for consideration at the June 18th Council meeting. If sponsored by the City Council, these ordinances would be placed under Ordinances for Introduction Each ordinance would address junked or abandoned vehicles and blight property.
 - ◆ An ordinance amending Title 17-Zoning, adding Chapter 17.05, Blighted Properties
 - ◆ And Ordinance amending Title 10-Vehicles and Traffic, adding Chapter 10.22-Junk Vehicles

We are requesting that the public take the time to review the drafted ordinances and provide your comments to the City Clerk.
