A RESOLUTION OF THE CITY COUNCIL, FOR THE CITY OF THORNE BAY, AMENDING RESOLUTION 18-09-04-01, RATE SCHEDULE FOR CITY SERVICES, FOR THE CITY OF THORNE BAY

WHEREAS, the City Council is the governing body of Thorne Bay, Alaska; and

WHEREAS, the City Council sets rates and fee schedules through resolution for all services provided by the City of Thorne Bay; and

WHEREAS, the City Council amends only the Solid Waste Fee and use schedule, in Resolution 18-09-04-01; in hopes that by reducing the rate for dumping per pound at the Solid Waste Facility, and increasing the days of operation, it will bring additional customers and increase overall revenues of the Solid Waste Department.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Thorne Bay amends Resolution 18-09-04-01 – Fee and Rate Schedule for City Services; and adopts the City Rate Schedule as set forth in this Resolution.

BE IT FURTHER RESOLVED, that the Solid Waste Site will amend operating days to be open every Thursday, Friday and Saturday, from 9am to 4pm.
