The City of Thorne Bay is requesting Proposals for construction of a multi-use community building. Dimensions of the one-story building are 36' x 76'.

Submission Requirements:

Notice for Submission provides the submission deadline and other details. Submissions must include the following information. Additional information will be accepted and considered during the review process

- Statement of Interest and Intent
- Company Profile (history, organization, specialization, etc.)
- Comprehensive List of Services Offered
- Experience with commercial / public building construction
- Customer References based on the above experiences, especially references from public entities
- Standard Contract / Standard Conditions
- Cost estimates

Compliance with Laws:

The Bidding Contractor will observe and abide by all applicable laws, regulations, ordinances and other rules of the State of Alaska and the City of Thorne Bay, Alaska and/or any political subdivisions thereof, or any other duly constituted public authority wherein work is done or services performed. The Bidding Contractor agrees to indemnify and save the City harmless from any and all liability or penalty that may be imposed or asserted by reason on the vendor's failure or alleged failure to observe and abide thereby.

Review Process:

Review of Proposals will begin following the submission deadline. Submissions may be reviewed based on the Submission Requirements and cost estimates. The City of Thorne Bay may contact references and perform other due diligence in evaluating submissions.

Selection Process:

Following review of submissions by the City Administrator, City Clerk and Mayor the contractor may be contacted for further information, an on-site interview, or selected outright. The selected Contractor will then be recommended to the City of Thorne Bay City Council to perform the work as detailed on the proposal(s) under an agreement or contract. On-site interviews should be expected and may be a requirement prior to or at the time of recommendation to the City Council. The approval will be for either the Clinic remodel, the Bay Chalet repairs or both. The City reserves the right to reject any and all submissions for any reason.




