## Election Worker Information

Thank you for your interest in joining our Election Team, as an Election worker for Thorne Bay. Becoming an Election Worker is a very important decision and requires making a serious commitment to the Team.

Election Workers are paid for the hours they work each Election day.

**Also, a Election Worker is required to:**

- I. be a registered voter in Thorne Bay
- II. be able to read and write the English language
- III. have reliable transportation
- IV. be able to work at least 14 hours on Election Day (no shifts)
- V. be able to fulfill your schedule if hired

After reading through the above information and feel you can meet the requirements, you may submit the application to the office of the City Clerk at 120 Freeman Drive, Thorne Bay, AK 99919, for processing.

The City Council appoints Election Judges at their second meeting in September each year. If you are selected to serve as an Election Worker, you will be notified by the Clerks Office the following day (third Wednesday of September).
