### 1) CALL TO ORDER:

Mayor Burger called the meeting to order at 6:33 pm

### 2) PLEDGE TO FLAG:

### 4) APPROVAL OF AGENDA:

Burger moved to approve the agenda. Hartwell seconded the motion. There was no further discussion.

### 5) MAYOR'S REPORT:

#### Mayor Burger reported on the following:

- Greg Kerkof, surgery in Anchorage with complications and will miss the next few meetings while recovering
- > COVID still going around

### 6) ADMINISTRATIVE REPORTS:

a) City Administrator:

Administrator John Huestis reported on the following:

- > Working on typical summertime maintenance issues and special projects as required
- Hired Caitlyn Sawyer as our Library Director, started today.
- > Putting the finishing touches on the Claw Trail, should be done by Thursday.
- We worked with AP&T and Denali Commission to encourage them to apply for a Broadband Reconnect 4 Grant for Thorne Bay, \$100K from Denali in support.
- > Tonsgard took the recycled metals and vehicles from the solid waste facility.
- Mike Williams will be drilling and shooting the rock in cell no. 2 at the landfill now that the

metals are gone and before it fills up again. We plan to sell the shot rock to a nearby RAC project and also level the site for future operational efficiency.

- Between the Claw Trail, the Kasaan Road Intersection and the Kasaan Road Heavy Maintenance/Super ditching project we will be using the rest of our D-1 and will need to make more to finish those projects and for future projects and general maintenance. I think we could get as much as 3,000 cubic yards from the shot rock at the City pit and I plan to get quotes and bring a Resolution forward at our next meeting to authorize the expenditure.
- I have completed a draft Management and Operations Plan for the next 50 years for our Solid Waste Landfill and have received favorable comments back from DEC. I will revise the plan according to the comments and submit the final plan. After this we will be seeking to implement the plan which includes closing the active cell, opening a new cell and expanding the operational area for better efficiency.
- The Kasaan Road Intersection RAC Project clearing and grubbing and slope staking are complete, next to remove stumps and place rock for AP&T to move their power poles, then continue excavation and rock fill. Will likely need to stabilize for winter and complete next spring.
- Kasaan Road 3 Mile Hill 2 weeks into that project, we budgeted for 8 weeks but got a late start so we may be able to get another 3 weeks or so on that project and maybe get more of it next year, we have several loose ends to tie up and winter is coming.
- > Reached out for information on Old Fire Hall Cleanup no response yet.
- SISD Floating Schoolhouse property prospective Lease for the property holding off on the MOA to see how this plays out - Did release SISD from their Lease.
- > I-90 Pontoon from Ketchikan Airport Project they backed out on giving it to us.

So after my visit which started on 14th of August when I found the Hendrix's were still living and blocking our lot, VPSO Mendonsa went to serve a ticket and make the Hendrix's who have been living in cul-de-sac on Alder Court for 6 years to move on April 23. I got a text stating the Hendrix's have moved off our lot line on Friday 26. When I asked if Hendrix's and all there 5 cars, boat, 5th wheel, Garbage, out house, loose dog and various others stuff were off the cul-de-sac I got no reply. So, since I felt Deja vu over this, it's looking like they are still breaking the law of the Thorne bay city codes, codes adopted from the State of Alaska. As repetitive as this may seem we were lied to in the past by City officials about who had the responsibility for said roads. So now we can only ascertain no ticket issued, just a another move to delay to the Hendrix's whimsy. Hendrix and the City of Thorne Bay have been keeping us from enjoying our cabin fully and progressing with work at the top of our lot. I'm afraid it's going to cost the city Money no matter what action you take. Delaying from solving a problem only makes thing bigger.

From the results of just last month, the city needs to motivate them more, how about all cars and vehicles and boats that are not licensed for this year to be removed, "Abandon"?. I'm sure the outhouse has not been inspected and site needs to be cleaned up. Just letting them move

20 feet or so to other side of cul-de-sac does not give us more security when pulling up. All of you know their reputation but you expect us to live under these conditions. I will tell you it does not matter if we are full time residence or not. I would be there a lot more with family if it was not a problem.

The Hendrix are either Lazy, or has moved back to our lot line out of spitefulness over time, or taking advantage of the generosity of the helpful people to help them because there poor. Its not a crime to be poor but when you "shoot yourself in the foot" as they say, when you are in need, over and over, yes it is going to generate a pattern, Which produce resentment on the party of the receiving end. From the start they have been antagonistic, not a way to have good first impressions.

25 to 30 years no one even knew who we were, now thanks to the Hendrix's last 6 years to put it mildly has not been fun.

WHEREAS, there were a total of one hundred and two (102) votes cast and counted during the October 4, 2022, Regular Election.

**NOW, THEREFORE**, THE CITY COUNCIL OF THE CITY OF THORNE BAY DOES HEREBY FIND, DETERMINE AND CERTIFY AS FOLLOWS:

**Section 1**. That the minutes of the October 10<sup>th</sup>, 2022, Council Meeting, reflect that the City Council certified the Election Results, reflecting a total of 102 votes cast, counted and reflected in the Certificate of the Election.

**Section 2**. That all proceedings in connection with the Regular Municipal Election have been accomplished according to law and the City Clerk is, hereby authorized and directed to deliver, or arrange for delivery of, a copy of the Certificate of Election to each newly elected councilmember.

## CITY OF THORNE BAY ORDINANCE 22-10-10-01

AN ORDINANCE OF THE CITY COUNCIL FOR THE CITY OF THORNE BAY, ALASKA, ADOPTING TERM LIMITS FOR ELECTIVE CITY OFFICES, BY AMENDING TITLE 2-ADMINISTRATION & PERSONNEL; CHAPTER 2.04-CITY COUNCIL; ADDING SECTION 2.04.035 TERM LIMITS

# BE IT ENACTED BY THE VOTERS FOR THE CITY OF THORNE BAY, ALASKA

- Section 1. <u>Classification</u>. This ordinance is of a general and permanent nature, the chapter and section hereby amended shall be added to the Thorne Bay Municipal Code if approved by the majority of the voters at the October 4, 2022, Regular Municipal Election.
- Section 2. <u>Severability</u>. If any provisions of this ordinance or any application thereof to any person or circumstances is held invalid, the remainder of this ordinance shall be and remain in full force and effect.
- Section 3. <u>Amendment of Section</u>. The title and chapter of Title 2-Administration and Personnel, Chapter 2.04-City Council; Section 2.04.035-Term Limits; is hereby amended and shall be added to the Thorne Bay City Code and read as follow:

# CHAPTER 2.04 – CITY COUNCIL.

**2.04.035. Term limits.** A person shall serve no more than two, three-year terms, or six consecutive years in office as a City Councilmember, provided however, that such person shall be eligible to hold such office after a break in service of thirty-six months.

- a) A full term in office of the City Council is three years.
- b) If any Councilmember has served 4 consecutive years in when their term has expired, they may only apply for and be elected to a seat that has a term of 1 to 2 years, so not to exceed the maximum of 6 consecutive years in office.
- **Section 4.** <u>Adoption</u>. Pursuant to the Alaska Statutes 29.26, this Ordinance shall be submitted to the voters of the City of Thorne Bay at the regularly scheduled election of October 4, 2022 and shall only become effective if a majority of

votes cast on the question of whether to adopt this ordinance favor adoption of this ordinance.

- Section 5. <u>Intent & Interpretation</u>. The City Council and the voters intend that an individual's previous and current terms of office shall be counted for the purpose of applying the term limits adopted herein, although all persons in office on the effective date of this Ordinance shall be permitted to complete their then-current terms.
- Section 4. <u>Effective Date</u>. This Ordinance shall become effective upon ratification by the voters of Thorne Bay. If a majority of Voters voting in the City's Election on October 4, 2022, approve the Proposition, the Mayor will sign this Ordinance and the Clerk will attest and certify the passage and adoption of this Ordinance at the Certification of Election to be held October 10, 2022

#### RESOLUTION 22-10-10-02 CITY OF THORNE BAY

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF THORNE BAY, ACCEPTING THE RESIGNATION OF COUNCILMEMBER GREG KERKOF FROM SEAT C, A TERM WHICH IS SET TO EXPIRE OCTOBER 2023; AND APPOINTING A REPLACEMENT TO SERVE AS THORNE BAY CITY COUNCIL MEMBER, IN SEAT C, UNTIL THE CERTIFICATION OF THE NEXT REGULAR MUNICIPAL ELECTION ON OCTOBER 1, 2023.

WHEREAS, on Councilmember Greg Kerkof was elected to serve on the Thorne Bay City Council Seat C, for a 3-year term beginning in October 2020, and

WHEREAS, on the 17<sup>th</sup> of September 2022, the City Clerk received notice that, Councilmember Kerkof was no longer able to serve as a Councilmember for the City of Thorne Bay due to unforeseen circumstances; and

**WHEREAS**, the City of Thorne Bay held their regular municipal election on October 4, 2022, where two candidates had applied for Seat B, and the City Council deems it to be in the best interest of the City to appoint Tiana Lavoie, candidate for Seat B, to City Council Seat C.

**WHEREAS,** in accordance with the Thorne Bay Municipal Code 2.04.110 Filling a Vacancy; the City Council by a vote of the majority of its remaining members shall designate one person to fill the vacant seat. That person shall serve until the next Regular City Election and until his successor qualifies; and

#### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF THORNE BAY, ALASKA:

- Section 1: That the above findings are hereby true and correct and are incorporated herein in their entirety.
- Section 2: That the appointment of Tiana Lavoie to serve as Council Member, Seat C, until the Certification of the Regular Municipal Election is held in October 2023, is hereby approved.
- Section 3: That this Resolution shall become effective immediately upon approval by the City Council of the City of Thorne Bay, Alaska.
