A Departmental Overview

The Water/Sewer Department is administered by Sam Sawyer, Level II Water Operator. The Supervisor(s) and staff are responsible for the operation and maintenance of the City's four core sanitation services: Water Treatment, Water Distribution, Sewage Collection, and Sewer Treatment. Duties include maintenance, minor and major schedule and unscheduled repairs throughout all four systems, monthly reporting to the Alaska Department of Environmental Conservation as required, direct sampling as scheduled for water quality and wastewater effluent quality compliance, implementation of a preventative maintenance schedule, construction of new water distribution mains and residential /commercial service connections and wastewater collection mains and residential/commercial service connections.

Current Department Activities:

Aside from working at the water plant and conducting our usual daily work, we will be working at the sewer plant.

Willie passed his Level I Water Treatment .

Department report for Harbor/Parks

Harbor is at capacity in both harbors.

- In main harbor A and B floats which moor annual boats are at 100% capacity
- C float and skiff slips which are seasonal are at half capacity and expected to be at full capacity during season
- D float, otherwise know as the seaplane dock is full on east side with planes and the west side houses the Forest Service barge
- All big boat slips at Davidson landing are at 100% capacity
- Skiff slips at Davidson which are seasonal are at half capacity and expected to be at full capacity during season

Current projects

- I am currently working on renovating Harbor office, in drywall phase right now, painting within a week
- Boat ramp hoop replacement has been delayed several times , we are currently waiting on treated lumber which has been ordered and will commence soon
- Several improvements on city park playset has been brought to my attention and will be extending swings in order to lower them closer to ground and replacing steering wheel , work will be done in February
- Grass seed will applied to dirt areas of park in the spring

AN ORDINANCE OF THE CITY COUNCIL FOR THE CITY OF THORNE BAY, ALASKA, AMENDING
TITLE 2- ADMINISTRATION & PERSONNEL, CHAPTER 02.04-CITY COUNCIL, SECTION
02.04.130-MEETINGS--REGULAR, SUBSECTION (A) DAY OF MEETINGS HELD.

BE IT ENACTED BY THE CITY COUNCIL FOR THE CITY OF THORNE BAY, ALASKA

- Section 1.** Classification. This ordinance is of a general and permanent nature, the chapter and section hereby amended shall be added to the Thorne Bay Municipal Code.
- Section 2.** Purpose. The purpose of this ordinance is to amend meetings days from the first and third Tuesdays to the first Tuesday with the option to schedule a second meeting on the third Tuesday.
- Section 3.** Amendment of Section. The title and chapter of Title 02 Administration and Personnel, Chapter 02.04 City Council, Section 02.04.130 (A)-Meetings – Regular, is hereby amended and shall read as provided herein this ordinance.
- Section 4.** Severability. If any provisions of this ordinance or any application thereof to any person or circumstances is held invalid, the circumstances shall not be affected thereby.

AMENDMENT OF TITLE, CHAPTER & SECTION:

TITLE 02- Administration and Personnel
CHAPTER 02.04 – CITY COUNCIL

THE FOLLOWING AMENDMENTS SHALL BE ADDED TO THE THORNE BAY MUNICIPAL CODE AS PROVIDED IN THIS ORDINANCE

2.04.130 MEETINGS--REGULAR.

- A. **ONE** regular council meetings shall be held on the first ~~and third~~ Tuesdays of each month, **WITH AN ADDITIONAL MEETING ON THE THIRD TUESDAY AS NEEDED.** ~~Either~~ **THIS** meeting may be rescheduled for cause, but ~~two~~ **ONE**

monthly meetings shall be held, unless ~~one is~~ cancelled by the majority vote of the City Council.

- B. Regular council meetings shall be held at City Hall unless that meeting place is unavailable in which case the meeting may be held at another location designated by the council presiding officer. (Ord. 04-06-17-01 §4, 2004; Ord. 90-24 §5(part), 1990)

Section 5. Effective Date. This ordinance shall become effective upon adoption.

ORDINANCE 24-03-05-01

A NON-CODE ORDINANCE OF THE CITY COUNCIL FOR THE CITY OF THORNE BAY, ALASKA, APPROVING AN OPTION TO LEASE CITY PROPERTY TO ATLAS TOWER FOR UP TO THREE YEARS FOR THE PURPOSE OF DETERMINING ITS ADEQUACY FOR THE CONSTRUCTION AND LONG TERM OPERATION OF A COMMUNICATIONS TOWER AND IF FOUND TO BE SUITABLE FOR SUCH THEN THE EXERCISE OF THE OPTION CONVERTING TO A THIRTY YEAR LEASE AND AUTHORIZING THE MAYOR TO EXECUTE THE APPROPRIATE DOCUMENTS.

BE IT ENACTED BY THE CITY COUNCIL FOR THE CITY OF THORNE BAY, ALASKA

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. The purpose of this ordinance is to provide an option for the lease of City owned property to Atlas Tower for an initial testing period of three years with the possibility of them exercising the option and thus converting to a thirty-year lease for constructing and operating a communications tower, following a successful testing period.

Section 3. Lease Terms Summary. The City of Thorne Bay (Lessor) intends to enter into a long-term lease of city property (a portion of Tract EGP of Survey 93-6 located within A.S.L.S. 87-5 and the SW ¼ of Section 22, Township 71 South, Range 84 East) to Atlas Tower1, LLC of Boulder Colorado (Lessee) for the proposed purpose of erecting a communications tower that would host cellular telecommunications providers.

WHEREAS, Lessee has expressed a desire to construct and operate a communications tower in the City of Thorne Bay for the purpose of hosting cellular communications providers to improve the access and quality of cellular services and a larger coverage area in and around the City of Thorne Bay; and

WHEREAS, Lessor has certain properties that the Lessee, and/or their prospective carriers, have determined would be advantageous in providing these improved coverages and services and desires to lease the best location available for their tower; and

WHEREAS, the Lessee and the Lessor have negotiated in good faith to provide for a two-stage lease approach whereby the Lessor has agreed to the terms and conditions of a 30 year lease with up to four five year extensions should the property being considered be deemed suitable for the intended purpose after the Lessee perfects all aspects of the proposed project to construct the tower during a three year period of time called the "Testing Period"; and

WHEREAS, the Lessor agrees to provide the Lessee with an "Option" to initiate the lease anytime within the 3-year Option timeframe provided for the testing period to determine the suitability of the property for the intended purpose and other business related matters as may need to be undertaken by Lessee to substantiate

the long term investment in the property and initiate the lease by constructing a communications tower; and

WHEREAS, the Lessee has identified two other potential locations on City owned property in case their first choice as depicted in the Lease under Exhibit 2 does not prove to be a suitable location during the investigatory process known as the testing period; and

WHEREAS, the Lessor agrees that if the Lessee desires to change to one of the other two predetermined locations, the Lease Exhibit No. 2 and other provisions concerning the location of the Tower can be modified during the Testing Period to focus efforts on another City owned property without the need to come back to the City Council and start a new Lease Option Term so long as the process can still be completed within the three year Testing Period; and

WHEREAS, Lessee has agreed to pay a Lump Sum payment of \$2,000 upon signing the Lease for the Option which provides them complete access to the land for up to three years to perform the necessary preliminary engineering and permitting work necessary to successfully construct and operate a communications tower on the property during this time known as the Testing Period; and

WHEREAS, should the Lessee find the property suitable for said purpose, upon either a Notice to the Lessor or the initiation of construction of the Tower on the property, the Initial Term of the rent shall begin and the initial rate shall be \$500.00 per month with an annual increase of 2% over the previous year's rent plus a one-time Lump Sum payment of \$25,000.00; and

WHEREAS, Thorne Bay Municipal Code 2.56.190, 2.56.200, and 2.56.220 states City Council shall approve or deny the request for long-term lease agreements via non-code ordinance considering the type and value of the improvements proposed.

NOW, THEREFORE, BE IT RESOLVED that the City Council of Thorne Bay, Alaska, hereby approves and authorizes the Mayor to execute the attached lease agreement identified as Exhibit A, providing for a new thirty-year lease of municipally owned lands located on a portion of Tract EGP of Survey 93-6 located within A.S.L.S. 87-5 and the SW ¼ of Section 22, Township 71 South, Range 84 East which will be approximately 2,500 square feet in size for the purpose of the construction and long-term operation of a communications tower and other rights and benefits as are further substantiated in the Lease agreement itself attached hereto.

Section 4. Effective Date. This ordinance shall become effective upon adoption.

THORNE BAY MUNICIPAL CODE:

ARTICLE III. LONG TERM LEASE OR SHORT-TERM LEASE OF CITY OWNED REAL PROPERTY

2.56.190 LANDS AVAILABLE FOR LEASING-CLASSIFICATION OF LANDS.

- A. All lands and interest in land owned by the city, including tide and submerged lands, may be leased or rented as hereinafter provided. Thorne Bay RV Park, Thorne Bay Harbor Facilities, Parking and other service rented by the day, week, month or year are regulated in other sections of the Thorne Bay Municipal Code.
- B. Before accepting applications to lease lands, the city shall have zoned by ordinance or otherwise classified the lands in question for leasing and for particular land uses. No lease shall be granted except for the particular uses for which the tract is zoned or classified. The classification of a tract of leased land may be changed by ordinance after consideration by the City.
- C. No city-owned property shall be leased or otherwise developed prior to the assignment of a particular zone or the repeal of the reserved use classification.
- D. **Long Term Lease.** A long-term lease herein referred to as "Lease" may not exceed 30 years.
- E. **Short Term Lease.** A short-term lease herein referred to as "Rental Agreement" may not exceed 5 years. The City may in its discretion require amendments or revisions to the lease as a condition of approval for extension. Short term leases are subject to the specific short- term lease terms set forth in Article III.
- F. **Tideland Lease.** Tideland leases may not exceed 99 years. A Tideland Lease herein referred to as "Municipal Tideland Lease" may not exceed 99 years. Long term leases are subject to terms set forth in article iii.

2.56.200 LEVELS OF APPROVAL REQUIRED.

- A. Except as provided in subsection B and C, leases of city-owned property shall be authorized by non-code ordinance.
- B. Leases valued at ten thousand dollars or less and for a lease term (including the lessee's rights of renewal) of 5 years or less, and involving two acres or less, may be authorized by the council by resolution.
- C. All short-term leases or rental agreements may be authorized by the city council.

**NON-CODE ORDINANCE 20-11-17-01
CITY OF THORNE BAY**

2.56.220 TERM OF LEASES.

- C. Any Municipal Tideland Lease will be negotiated between the applicant and the city and be for a term not to exceed 99 years with the option of renewal, in the sole discretion of the city, for a period not to exceed 99-year increments and with such revisions and amendments as deemed by the city in the best interest of the city. The applicant shall state in the application the term desired. In determining whether to grant a lease for the requested term, the council shall consider the nature, extent and cost of the improvements which the applicant agrees as a condition of the lease to construct and the value of the other relevant factors. The term of any given lease shall depend upon the desirability of the proposed use, the amount of investment and improvements proposed to be made by the lessee, and the nature of the improvements proposed with respect to the durability and time required to amortize the proposed investment.

CITY OF THORNE BAY**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF THORNE BAY, APPOINTING A VICE MAYOR FOR THE CITY OF THORNE BAY, TO SERVE A TERM OF ONE YEAR, EXPIRING ON THE MONDAY FOLLOWING THE CERTIFICATION OF THE REGULAR MUNICIPAL ELECTION.

WHEREAS the City Council is the governing body for the City of Thorne Bay, and

WHEREAS the Thorne Bay Municipal Code Section 2.08.020 Vice Mayor, requires that the City Council meet on the first Monday after certification of each general election and shall elect a councilmember to serve as Vice Mayor for the term of one year; and

WHEREAS

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF THORNE BAY, ALASKA:

- Section 1: That the above findings are hereby true and correct and are incorporated herein in their entirety.
- Section 2: That the City Council appoints to serve as the Vice Mayor of the City of Thorne Bay and shall serve a term of one-year.
- Section 3: That this Resolution shall become effective immediately upon approval by the City Council of the City of Thorne Bay, Alaska.
