A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF THORNE BAY, ALASKA, ASSIGNING
CITY ADMINITSTRATOR, JOHN HUESTIS, AS THE REPRESENTATIVE-SIGNATURE-CERTIFIER,
AND CITY CLERK, CAITLYN SAWYER AND FINANCE OFFICER, TERI FEIBEL AS
ADMINISTRATORS, FOR SUBMITTING A CITY APPLICATION TO THE RURAL UTILITY SERVICE
(RUS), U.S. DEPARTMENT OF AGRICULTURE FOR THE RECONNECT 5 BROADBAND GRANT
FUNDING OPPORTUNITY

WHEREAS, the City Council is the governing body of Thorne Bay, Alaska; and

WHEREAS: The Thorne Bay City Council supports the deployment of broadband services in the City and intends to pursue grant funding from the USDA RUS ReConnect 5; and

WHEREAS, John Huestis is the City Administrator in charge of Grants and Contract Administration, Caitlyn Sawyer is City Clerk and Teri Feibel is the City Finance Officer; and

WHEREAS, USDA RUS grant application portal, RDAApply, requires a Resolution of the City Council for approval of the Authorized Representative Request assigning a Representative-Signature-Certifier and Council designated Administrator(s) for special security roles in administering the grant application intake/submittal processes for the Reconnect 5 Grant.


NOW THEREFORE BE IT RESOLVED that the City Council of the City of Thorne Bay, Alaska, hereby approves and assigns, John Huestis, the City Administrator of the City of Thorne Bay, to the Rural Utilities Service assigned Representative-Signature-Certifier security role and entering an application, completing electronic stages, submitting applications, providing signatures, and authorizing certifications for the applications to RUS, an agency of the United States Department of Agriculture; and,

NOW THEREFORE BE IT FURTHER RESOLVED that the City Council of the City of Thorne Bay, Alaska, hereby approves and assigns City Clerk of the City of Thorne Bay, Caitlyn Sawyer and Finance Officer of the City of Thorne Bay, Teri Feibel, as Administrators on behalf of the City of Thorne Bay, who shall be responsible for assigning access to new users and entering/updating application(s) in USDA's Online Application Intake System for Telecommunications Programs. If applications are awarded under these Programs, the Administrator(s) security role on behalf of the City of Thorne Bay, shall also be responsible for assigning access to new users and entering/updating compliance reports in USDA's Online Financial Reporting Compliance System; and,

NOW THEREFORE BE IT FURTHER RESOLVED The Representative-Signature-Certifier and Administrator(s) for the City of Thorne Bay shall comply fully with all security procedures


and policies of the Online Application Intake System for Telecommunications Programs and USDA's Online Financial Reporting Compliance System.
