A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF THORNE BAY CERTIFYING THE ELECTION RESULTS AND ALL PROCEEDINGS IN THE OCTOBER 7, 2025, REGULAR MUNICIPAL ELECTION

WHEREAS, the City Council is the governing body for the City of Thorne Bay, Alaska; and

WHEREAS, the City held a Regular Municipal Election on October 7, 2025, for the purpose of filling three (3) vacant council seats; and

WHEREAS, notice of the City Election was duly given per the Thorne Bay Municipal Code Chapter 2.28- Elections; and

WHEREAS, the City Council received from the City Clerk, a Canvass Report and Certificate of Results of the Regular Election ("Certificate of Election"); and

WHEREAS, there were a total of 70 votes cast and 69 votes were counted during the October 7, 2025, Regular Election.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF THORNE BAY DOES HEREBY FIND, DETERMINE AND CERTIFY AS FOLLOWS:

Section 1. That the minutes of the October 13th, 2025, Council Meeting, reflect that the City Council certified the Election Results, reflecting a total of 70 votes cast, and 69 votes were counted and reflected in the Certificate of the Election.

Section 2. Timber Pesterfield is Elected to Seat A, for a Three-year Term with a total of 63 votes, Gary Anderson is Elected to Seat B, for a Three-year Term, with a total of 50 votes, Thomas Cunningham is Elected to Seat C, for a Two-year Term, with a total of 51 votes.

Section 3. That all proceedings in connection with the Regular Municipal Election have been accomplished according to law and the City Clerk is, hereby authorized and directed to deliver, or arrange for delivery of, a copy of the Certificate of Election to each newly elected councilmember.

PASSED and ADOPTED this 13th day of October 2025, by a duly constituted quorum of the City Council for the City of Thorne Bay, Alaska.
